PREREQUISITES

- All trainees must:
 - Be a licensed Esthetician, a Spa owner- OR -
 - Currently enrolled in a beauty school (verifications will be required)
 - Have an active personal liability insurance (for the hands-on training class)
 - All students must follow their state licensing rules
- Complete an online application and be approved by the company

Trainees are encouraged to be wax models for one another during their hands-on training. If it's an 1-on-1 class you will also receive a wax from the trainer, and get to watch a detailed demo on a model.

OVERVIEW OF COURSE

- Our mission is to provide our trainees with a quality education. *The Wax Haus Method*® offers courses in hard waxing techniques and education, for estheticians invested in becoming wax experts that provide safe waxing services with exceptional results.

LEARNING OBJECTIVES

- During the class we will cover many topics that are necessary for you to take into consideration before you wax someone's face. We will give special attention to brow shaping/design and detailed wax techniques for small areas.
- We will include the following topics and much more:
 - How to do a consultation with a client before any wax service
 - Client release forms that are required
 - How to handle skin reactions and breakouts after waxing any area

- How to determine which eyebrow design would be ideal for each client
 - How to shape and trim the eyebrows
 - How to identify skin and waxing contraindications
 - What products to use before and after waxing
 - The importance of High Frequency
 - How to easily apply and remove small wax patches
 - How to avoid wax accidents and prepare for if something goes wrong
 - How to fill in the brows with powder
 - How to educate your client and after-wax suggestions

METHODS OF INSTRUCTION

- *The Wax Haus Method*® is an educational waxing class with lectures, live waxing demos and hands-on participation.
- Each waxing course can be offered as: Demo only, Hands-on participation, One-on-one training.
- Trainees will have the opportunity to observe the instructor waxing a model while being guided through the process in detail, followed by an in-depth Q&A session.
- Company will provide all supplies and wax products needed for this training.

WORKLOAD

- Training is done in a single day and the day is split into 3-4 sessions.
 - Session 1 - Manual Review
 - Session 2 - Face & Brows Wax Demo
 - Session 3 - Q&A
 - Session 4 - Hands on Training with one waxing model (when you sign up for this training)

WAX MODEL REQUIREMENTS

- Students are highly encouraged to participate as a wax model for each other during their hands-on training session so they can better understand the techniques they are learning, and the experience it provides. If you need a waxing model, please

request for one to be provided for you ahead of time with an additional fee of \$150/model.

- All waxing models must have at least ½" long (or longer) hair growth in order to be eligible as a waxing model for the training session. This is about 3-4 weeks post-shave/wax growth.
- All wax models must complete a release form ahead of time and will be required to list personal health information including allergies, medications, and other related health conditions.

PAYMENT

- Full payment for each course is due at the time of registration.
- Payment is not refundable in case of a late cancellation or a no-show.
- Paypal, debit and credit cards are accepted.
- Payments from State or Federal student financial aid programs will not be accepted.
- No refunds will be given to the trainee after taking the class. No exceptions.

CERTIFICATION

- Each student that is in attendance and actively participates in the training will receive a digital certificate of completion following the hands-on course.
- Certification will not be given for a Demo class.

OFFICIAL COMPANY ENDORSEMENT

- To be added to our list of preferred/recommended wax experts, you must apply for an official endorsement by Wax Haus and Skin and *The Wax Haus Method*®. This is in addition to the certificate of completion.
- In order to receive an official endorsement by our company, you must take a hands-on class, complete and submit an online assessment and application.
- Your training day performance will be under review in addition to your application, and if approved, you will receive the official Certified Seal of *The Wax Haus Method*®.

ATTENDANCE/TARDINESS

- All trainees are expected to show up a minimum of 15 minutes before the start of the scheduled training session. Check-in for training will begin 30 minutes prior to the start of the first session.
- The training will begin promptly at the start time, and any material missed by a tardy student will not be reviewed.
- In the event of a class cancellation the trainee will not be entitled to a refund but will retain their credit towards a future class.

MISSED TRAINING/RESCHEDULING

- Trainees must give 7 days notice via email if they need to cancel or modify in any way their scheduled training day. Emails should be sent to **dee@thewaxhausmethod.com**.
- Any trainee who fails to communicate their absence, without verifiable extenuating circumstances, will be charged a \$200 no-show fee in order to retain their training credit, and reschedule their training at a future time.

TERMINATION

- A trainee will be dismissed from training without refund if they fail to meet the behavioral expectations for the courses.

 - Verbally or physically threatening another trainee, guest or instructor;

 - Willfully or intentionally damaging or destroying the company property.

- A post-course survey will be sent out via email immediately following the training sessions.
